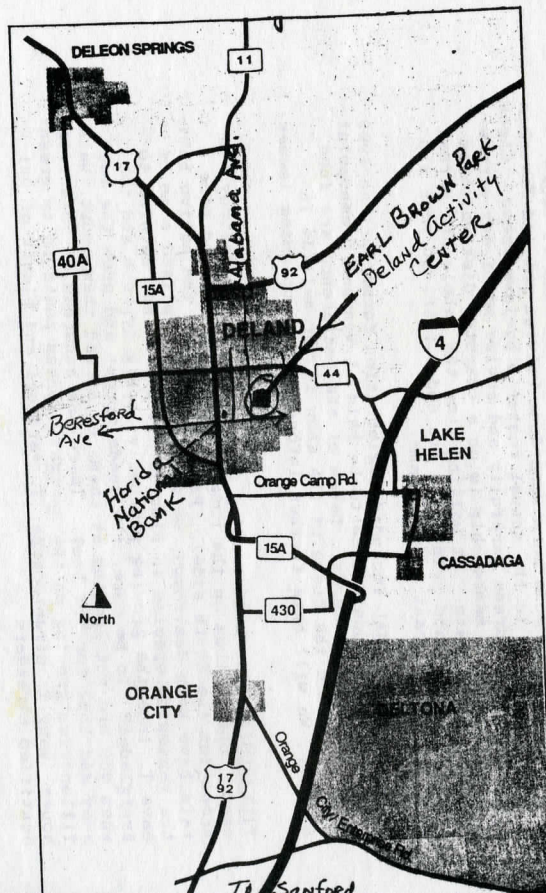
BSI members please remember to cast your vote for director prior to September 1.

Would it not be nice to have *T. ionantha* growing profusely in Big Cypress and the Everglades? To be sure, the seeds sprout and grow the best when you are not looking at them, so spread them about, walk away and hope for the best. There are hundreds of volunteer Tillandsias growing on the upright cypress posts in my greenhouse--many *T. streptocarpa*, *T. gardneri* and plenty of unidentified strangers.

MINUTES OF THE F.C.B.S., JULY 8, 1989 MEETING

The meeting was held at the home of Bob Steiger, New Port Rickey, Florida. Bob is our new West Pasco Representative.

Nat DeLeon opened the meeting by thanking the Host, Bob Steiger and his helpers for a delicious meal. He then introduced Bob Steiger and Gwen Carnegie as the new West Pasco Representatives, and Jim Boington as President and stand-in Representative for Florida West Coast Bromeliad Society. Also standing in for Imperial Polk was Whit Merrin. Visiting was Mike Q'Leary, President of the Bromeliad Guild of Tampa Bay.

MINUTES: Minutes of the April 8, 1989 meeting were approved as written.

TREASURER'S REPORT: Carol Johnson submitted the report. Discussion ensued on the item of extra postage costs for out of country newsletter mailings. Carol stated that it costs approximately 90¢ more to mail each issue out of the U. S. A. or \$3.60 per year. After much discussion Connie Johnson stated that since most of the foreign members were from the South Florida Society, she would have Carol Johnson mail them to her and she would mail them out of the country and bill the Bromeliad Society of South Florida.

The report showed a balance of \$2,087.82. It was approved as written.

OLD BUSINESS

FLORIDA COUNCIL EXTRAVAGANZA: Charles Tait reported that August 19th, Seminole Bromeliad Society would sponsor a plant sale in DeLand, Fl., from 9:00 A. M. to 3:30 P. M. at which time Harry Luther would speak followed by food (buffet) at a nominal fee of approximately \$3.00 to \$4.00 per person. Each person would be responsible for paying for their own meal. At approximately 7:00 P. M. there would be a semi-rare plant auction. It was suggested that the three (3) plants that are to be brought by each affiliate representative would be in the \$15.00 to \$35.00 price range, showey, and possibly variegated, to attract the general public.

STATE SHOW: Charlest Tait reported that the Florida State Bromeliad Show will be held September 1st to 3rd at the Florida Mall in Orlando, Florida and hosted by the Bromeliad Society of Central Florida.

Carl Perryn stated that he was in charge of raising money for some 22 awards. The awards would be \$20.00 each for any affiliate or individual who is willing to sponsor one. Advertising in "The Beginners Guide to Bromeliads" publication is also available to any person or business who wishes to do so. Carl Perryn suggested that the Florida Council sponsor

the sweepstakes award. Carl also stated that Central Florida is planning to dedicate the State Show to Racine Foster. Representatives are to talk-up the event and get people to attend the dinner and auction, September 2, 1989 at the Charles Branneky residence, 2004 Gatlin Avenue; Orlando, Florida. Proceeds will go to the Mulford B. Foster Identification Center at Selby Botanical Gardens.

STATIONARY: Carol Johnson stated that the new stationary is on the way to the printers and will be available soon.

RARE PLANTS BEING REPRODUCED AT SELBY GARDENS: Neither Edith Howells or the Sarasota representatives were in attendance to make a report. Nat suggested compiling a list of species or good hybrids that would be good candidates for tissue culture and then contact Selby or a private lab to see if we could stimulate some interest in reproducing these plants.

JUDGES SCHOOL AND SYMPOSIUM: Roland Schnabel reported that 19 B.S.I. Certified Judges attended the Symposium including four judges who needed recertification.

There were 14 B.S.I. Student Judges who attended the school and Roland said that there is one more school plus the test to complete the school. Roland also encouraged the Affiliates who are having standard shows to invite their participation in order to help them get qualified.

Roland suggested that anyone who wanted to know anything about which Student Judges needed to be qualified, in any area, to contact Jean Schnabel, the new Judges Registrar, for that information.

ARTICLES FOR THE F.C.B.S. NEWSLETTER: Carol Johnson stated that she would like to see some comments on the conservation issue. Should Bromeliads be put on the endangered species list or should they be withheld?

Nat DeLeon suggested making a motion to support the B.S.I.'s position on conservation as per Mark Dimmitts' report. Mark is the B. S. I.'s Conservation Chairman.

Carol Johnson entertained a motion to support the B. S. I. position on conservation and send Kew Gardens a formal letter stating that the F. C. B. S. did this and that we represent many growers in the State of Florida and that we support this effort. Charlie Tait seconded and the motion passed.

Tom Wolfe suggested that a committee be formed to represent F.C.B.S. and talk to Harry Luther and Larry Pardue of Selby Gardens in order to firm-up a formal agreement between Selby Botanical Gardens, The Bromeliad Identification Center, B.S.I., and the F. C. B. S. This would hopefully give the F. C. B. S. some control of the disposition of such items as being discussed in the event that F.C.B.S. decided to place them at Selby where they would be utilized to the fullest by "Bromeliad People."

Nat then appointed Ron Schoenau, Tom Wolfe and Carl Perryn to serve as a committee to carry out this purpose.


Nat stated that when we find out what is in these collections, we can make a decision as to what to retain at Selby or wherever permanent place is decided upon and what items should be auctioned or sold. The later being items that are duplicates or items that would have no practical value to bromeliad people.

1990 STATE SHOW: Nat stated that he would call the Sarasota rep's to find out if the Sarasota Affiliate would be interested in sponsoring the 1990 State Show.

Roland Schnabel stated that the Bromeliad Guild of Tampa Bay maybe interested in sponsoring the 1991 Show.

NEXT F. C. B. S. MEETING: The Bromeliad Society of Central Florida is responsible for hosting the next meeting.

Man sentenced to prison for taking jungle orchids

LONDON — A judge Tuesday convicted and jailed an Armenian-born man who admitted plundering rare orchids in jungles around the world.

Henry Azadehdel, 37, who fled to Britain from Iran in 1979, pleaded guilty Monday to four counts of smuggling, harboring, offering for sale and selling restricted orchids. This violates the Convention on International Trade in Endangered Species.

Judge Derek Clarkson imposed a one-year prison term but suspended two-thirds of it and ordered Azadehdel to pay a \$15,700 fine and \$15,700 toward the prosecution's costs.

Lawyers said the offenses carried a maximum two-year sentence.

The judge said Azadehdel destroyed the orchids not as an over-enthusiastic collector or amateur with a genuine curiosity in plant species but for "substantial commercial exploitation."

Prosecutor Andrew Mitchell

said it was the first conviction under the treaty for taking orchids from their natural habitat.

He said Azadehdel had "raped beauty spots around the world" of wild orchids "to fatten his bank account."

Mitchell said customs officers stopped Azadehdel upon his return from a visit to Peru and Ecuador in 1987. They apparently thought he was a drug smuggler because of his frequent trips to South America and Southeast Asia.

In his baggage, officers found 14 slipper orchids worth more than \$5,370. Azadehdel said he did not know what they were and that he paid \$2.30 for them.

Customs officers, assisted by Dr. Philip Cribb, an authority on orchids, removed 365 endangered plants worth more than \$75,000 on the black market from a greenhouse at Azadehdel's home. The orchids were given to the Royal Botanical Gardens at Kew.

Mitchell said Azadehdel made more than \$400,000 dealing in rare orchids between January 1985 and November 1987.

FLORIDA COUNCIL OF BROMELIAD SOCIETIES

BY-LAWS

ARTICLE I

The name of this organization shall be the Florida Council of Bromeliad Societies, Inc. herein referred to as the Council.

ARTICLE II

Objective: The objective of the Council shall be to serve the bromeliad enthusiasts of Florida among the member societies, the subscribing members and the public-at-large by:

1. Furnishing in periodical form articles and features of interest to Florida Bromeliad growers.
2. Sponsoring state-wide bromeliad conferences and/or shows.
3. Compiling and maintaining educational programs and materials for members and the public-at-large.
4. Other such measures as the Council may from time to time deem appropriate.

ARTICLE III

Section 1. The membership of the Council shall fall into the following categories: A. Active

Section 2. Active membership shall be limited to the representatives of Bromeliad Societies of Florida as specified in Article V.

Section 2-A: To be eligible for active membership, the applicant must be a member in good standing of a society having a minimum of ten (10) members, and must submit a copy of that societies' Bylaws to the Council for approval. Application for membership constitutes approval and acceptance of the Council's Bylaws by the applicant.

Section 2-B: Application for active membership shall be made to the Secretary of the Council. Admission to Council will be granted by a majority vote of a quorum at the next regular meeting following application.

Section 2-C: Dues for an active member shall consist of an initial contribution of \$50.00 and annual dues of \$10.00.

ARTICLE IV

Section 1: Dues shall be payable by Dec. first for the following year, after written notice in September.

Section 2: Failure by active members to pay dues shall result in automatic suspension. A suspended active member may be reinstated by payment of all back dues and a majority vote of the active members.

ARTICLE V

Representation

Section 1: Each affiliate society shall be entitled to elect or appoint from its membership two (2) representatives to the Council. Representatives shall begin their terms at the first regular meeting of the year. In the event a representative is unable to attend a Council meeting, the affiliate may choose to send an alternate. Each representative or alternate shall have full voting rights.

Section 2: If there are compelling reasons for the removal of a representative from the Council, such removal shall require a two thirds (2/3) vote of the active members and a minimum of 30 days advance notice of the question in writing to all members.

Section 3: To hold the position of officer of the Council, a representative must have served on the Council as representative for at least six (6) months.

Sec. 4: All reps will be expected to maintain good attendance at meetings.

Section 5: All BSI Directors shall have a standing invitation to, and must be notified of all meetings. Such Directors will not have voting rights.

ARTICLE VI

Officers

Section 1. Officers of the Council shall be Chairman, Vice Chairman, Secretary and Treasurer. Rotating officers of the Council shall be Chairman, Vice Chairman and Secretary. Elected permanent officer of the Council shall be the Treasurer. When the Treasurer is not an elected Junior or Senior rep from his society, this office shall be non-voting.

Section 2. Senior members shall assume office for one year at the opening of the first regular meeting of the calendar year on a rotating basis with the rotation to be established at the time of adoption of these By-Laws. In any given year the Senior member of the affiliate society that are first, second and third in the rotation shall hold respectively the offices of Chairman, Vice Chairman and Secretary. In the following year the affiliate society whose Senior active member held the chair shall move to the bottom of the rotation and all other affiliate societies shall move up one place in the rotation.

Section 3. Any new active member shall enter the rotation for officers at the bottom in the initial year of their membership and may not hold office as specified in Section 5 of this article.

Section 4. All out-going officers shall deliver to their successors all records and materials relative to their office at the opening of the first regular meeting of the year.

Section 5. In the event of a vacancy among the officers, the senior member of the affiliate society at the lowest point of the rotation who meets the following qualification shall fill the office for the remainder of the year. Such a replacement officer must have served the six months prior to the last rotation of officers as a Junior member. If no member meets this qualification the Council shall elect from among the members the individual best suited to the office in question. This contingency will not alter the normal rotation.

ARTICLE VII

Duties of Officers

Section 1. The Chairman shall preside at meetings, appoint committee chairmen as provided for in the By-Laws, act for the Council when not in session, carry on correspondence for the Council and perform other duties as may be directed by the Council.

Section 1-B: The Chairman shall appoint a chairman for the following committees and other such committees as the Council shall deem necessary:

Section 1-C: The Chairman shall be ex-officio member of all committees.

Section 1-D: The Chairman shall appoint a Parliamentarian who shall direct, when necessary, proper parliamentary procedure during meetings.

Section 2-A: The Vice Chairman shall be Show and Conference Co-ordinator with the responsibility for keeping Council rules and procedures relating to shows and conferences up to date, and for providing such data to host societies.

Section 2-B: The Vice Chairman shall be acting Chairman when the Chairman is not in attendance at meetings.

Section 3: The Secretary shall keep all minutes, books, papers and records of the Council, and shall maintain an up-to-date roster of all active members and their representatives.

Section 4: The Treasurer shall be responsible for all funds of the Council; shall give and receive receipts for funds received and disbursed; shall deposit such funds in a recognized depository; and shall keep accurate accounts so that any member of the Council may at any time have full access thereto. Any expenditure in excess of \$50.00 must have prior approval of a majority of the active members.

ARTICLE VIII

Voting

Section 1-A: Each affiliate society shall have two votes on any question before the Council, such votes being cast by the Senior and Junior representatives to the Council for each affiliate society.

Section 1-B: The Chairman or Acting Chairman shall cast an additional vote in the event of a deadlock.

Section 2: Representatives of two thirds (2/3) of the affiliate societies constitutes a quorum and, except as otherwise provided herein, a majority of a quorum may decide any question.

Section 3: Any informal vote, phone or mail, must be carried by a majority of the affiliate societies, and the Chairman must mail the details of any such informal vote to all Senior members immediately.

Sections 4: The members of the Council shall be empowered by the affiliate societies to conduct any and all business of the Council and shall have complete control over the affairs and funds of the Council by this authority.

Section 5: There shall be no proxy or absentee votes cast at a regularly assembled meeting of the Council. Only those members in attendance may cast a vote.

ARTICLE IX Meetings

Section 1: Regular meetings of the Council shall be held on the second Saturday of January, April, July and October. Deviations from regularly scheduled meeting dates will be permissible if approved by a majority of representatives from member societies and the host society at least 30 days prior to the date of the regular meeting.

Section 2: The Chairman may call special or emergency meetings when deemed necessary.

ARTICLE X Shows

Section 1: The Council shall sponsor an annual statewide Bromeliad Conference and/or Show to be hosted by affiliate societies on a rotating basis.

Section 1-A: The Council shall establish rules and procedures governing the management of shows and conferences. These rules and procedures, when established, shall be an addendum to the By-Laws and shall be subject to the same voting procedures as other questions. **SEE ADDENDUM.

Section 2: There shall be a general plant sale at each annual show.

Section 2-A: The Council shall establish rules and procedures governing the management of the plant sale. All members of affiliate societies may take part in the plant sales and shall abide by these rules. **SEE ADDENDUM.

ARTICLE XI

The rules of parliamentary practice set out in Robert's Rules of Order, newest Revised Edition, shall govern the proceedings of the Council, subject to any special rules the Council may adopt.

ARTICLE XII Amendments

Section 1: Any proposal to amend these By-Laws shall be submitted to the Chairman in writing at least sixty (60) days prior to the next regular meeting. A copy of the proposed amendment shall be mailed by the Chairman to each member at least thirty (30) days prior to the meeting in which the amendment will be considered. An affirmative vote by at least two thirds (2/3) (as specified in Art. VIII, Sec. 1-A) shall be required for adoption of any amendment.

Section 2: In the event of an emergency requiring amendment of these By-Laws, with the recommendation of the Parliamentarian and a unanimous vote of the members, these By-Laws may be amended. This procedure waives notice as required in Section 1.

ARTICLE XIII Sunset Clause

In the event that the active membership of the Council should ever decrease to three, this Council shall be dissolved at once. Any funds in the treasury will then be donated to the Mulford B. Foster Bromeliad Identification Center, to be used for bromeliad research.

ADDENDUM TO BY-LAWS OF FLORIDA COUNCIL OF BROMELIAD SOC. INC

Article X

SHOWS

Section 1-A. Rules and procedures governing management of Florida State Bromeliad Shows & Conferences, hereinafter referred to as FSBS.

Section 1-A-1: General

A. Dates for FSBS shall be set 3 years in advance by the host society with the approval of the Council. Exceptions shall be made only by a majority of Council members in regular session. Affiliate societies who are members of the Council shall be required to honor date selections for FSBS by not scheduling local shows within ten (10) days before or after the FSBS date.

B. Actual operation of FSBS shall be subject to rules set up by the host society with the following exceptions:

1. Judging shall be in accordance with the "Handbook for Judges & Exhibitors" as published by BSI.

2. Hybrids of unknown parentage shall not be eligible for major awards except as follows:

a. "Grandfathered" by Hybrid Identification List of BSI.

b. In process of registration but not yet published by BSI.

3. Plant sale rules shall apply to all Florida Bromeliad Societies & their individual members equally.

C. To be eligible to host the FSBS, a Council member society shall have staged a minimum of two local standard bromeliad shows, as defined by the above "Handbook" with one show accomplished before application and two shows before the actual date of the FSBS.

Section 1-A-2. Financing

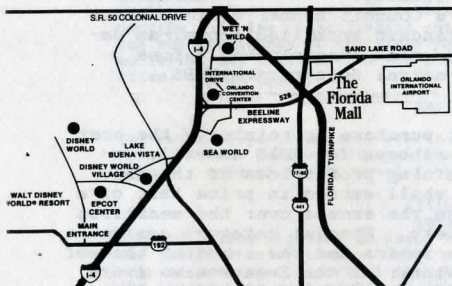
A. AWARDS. The Council shall either purchase or reimburse the host society for all top awards and other ribbons for FSBS and this expense shall not be a factor in determining profit/loss of the show; provided, however, that no top award shall exceed in price that of a BSI unmounted medallion, in which case the excess over the medallion price shall be borne by the host society. Special category awards shall be financed by individual subscription and the awarding thereof at the option of the host society. Winner of the Sweepstakes Award at each FSBS shall be awarded a plaque by the Council, properly engraved with the place and date of the FSBS; PROVIDED, however, that all provisions of Article X (Sec. 1-A-1; items B-2, a & b) are strictly observed by the host society when computing the award.

B. PROFIT &/or LOSS from a designated FSBS shall be shared equally by the Council and the host society. It shall be the duty of the Vice-Chairman of the Council to work with the host society in all matters concerning a FSBS and file a final written report with the Council at a regular meeting prior to the close of his/her term of office.

Section 1-A-3: Adoption. Adoption of this amendment shall be in accordance with Article XII & Article VIII, Sec. 1-A of the existing by-laws.
