The new Garden Activities building at Harry P. The Gardens will publicize the event in their magazine and through the media, so as to get a big turnout from the public. BSCF is contacting nearby motels for special rates for our overnight guests. There will be further details as plans go forward, but by all means mark your calendar.

Three people have recently asked me for seeds from Aechmea orlandiana. I do not have any, but the plant often self-seeds. If you by chance have any, please save them and send them to me and I will get them distributed.

Any contributions of garden related cartoons or line drawings of plants would be welcomed. They are needed to fill in the pauses at the bottom of the pages of this Newsletter. This issue of the Newsletter marks the beginning of my 15th year as Editor. It all began as an effort to replace the then-recently-defunct "Grande". The first two years the pages were run off at the printer, then I took them home, collated, folded and stitched (stapled) them. Mailing labels were prepared by photocopying master sheets onto pages of mailing labels. In order to conform with bulk mail procedure, the entire lot was sorted by hand into zip-code bundles. In 1982 I began the process of securing non-profit status from IRS for Florida Council in order to obtain the much lower postal rate. It took almost two years to finalize our 501(C)3 status and this was done without any legal assistance or expense. From that experience I learned that common-sense and persistence pay off.

In the second year I developed a "trigger" thumb on my right hand. The pain forced me to do something which should have been done all along—have the collating, folding and stitching done by the printer.

In 1986 I purchased my first PC and soft ware which enabled me to run my own mailing labels in zip-code order. It was wonderful. Now, I can label, sort and bundle the entire issue in 3 hours. My PC has also made it possible for me to print the entire state roster in alpha order for the annual edition, which previously had been a dreaded menial typing job. I have always done all the layout and pasting (you noticed, huh?). Now that I have a FAX it would be feasible to have all the copy typeset (costs more) without having to make numerous trips to the printer with corrections.

In the beginning the Newsletter was, of necessity, a bare-bones project. There have been numerous complaints about the small print, which I can understand. However, print reduction makes it possible to put twice as much material in half the space for the same price. In 1993 FCBS furnished me with a new PC printer (also a file cabinet) and the change in the Newsletter format is undoubtedly noticeable. I would like to hear from the membership. Do you want a classy, slick, expensive Newsletter at much greater cost or is the present arrangement adequate? I would like to hear some opinions.

Cost of the present Newsletter (see Annual Financial Report this issue) is:

Present mailing is 720/730 per issue or a total of .57345 each, or \$2.29 for all four issues. Each member society of FCBS is billed in August of each year at \$1.00 per member address to defray Newsletter costs and you can see that does not whack it. However, generous support of the annual rare plant auction at the Extravaganza has made our financial situation much more satisfactory. Mailing cost will increase with this issue. It was formerly .113 per copy and will increase to .116.

In all those fourteen years, even with repeated requests, there have been probably ten contributions of articles from the membership. If I make a mistake or step on a toe or two, I hear plenty, otherwise nothing. I have made it a policy not to use the many really good articles in the other society newsletters I receive (thank you), since they need to swap them around among themselves. Beginning this year, there will be no obituaries, because eventually I would miss one and hurt the feelings of one of my dear friends. Please, if you have information for the Newsletter, write it down and mail it to me. Then I will be responsible for any errors. In this issue, I am guessing about some of the show information, but it seemed important that it appear.

Only one copy of the Newsletter is mailed to an address. So, with many dual memberships, we are new reaching in excess of 1,000 members.

Minutes of Business Meeting held January 14, 1995 Hosted

PRESENT: Representative from Caloosahatchee (Sam, Hattie Lou Smith), Central Florida (Ed Hall, Carol Johnson), Florida East Coast (Ted Nuse), Florida West Coast (Lois Duffey), Imperial Polk (Carl Perryn, Whit Merrin), Jacksonville (Carolyn Schoenau, Al Muzzell), Tampa Bay (Tom Wolfe, Judy Patterson) Sarasota (Wally Berg, Jane Dahlin) South Florida (Nat DeLeon), West Pasco (Evelyn Hayes).

ABSENT: Seminole and Broward.

GUESTS: Howard Frank, Ron Schoenau, Peggy Nuse, Nancy Hall, Betty Ann Prevatt, Gene McKenzie, Diane Molnar, Alton Lee and Peggy Bailey.

- 1. Call to order: The meeting was called to order at 1:15 pm by Chairman Ed Hall.
- 2. Secretarial report: The secretarial report has been distributed previously with the meeting agenda. It was moved and seconded that the minutes stand approves with the following addition: #5, Extravaganza-Auction proceeds of \$2,465.50 were received. Motion carried.
- 3. Treasurer's Report: Carol Johnson distributed the Treasurer's report for the fourth quarter and the whole of 1994, ending 12-31-94. A copy is appended to the minutes.
- 4. Evil weevil report: Dr. Frank reported that he had sent parasitic weevil flies to be reared by Ronald Cave in Honduras. He is providing assistance to a Univ. of South Florida graduate student who is doing a study on enemies of bromeliads in nature.
- 5. Extravaganza Auction Policy: Handouts containing suggestions of auction guidelines were prepared by Lois Duffey and Geoff Johnson. Since both sets of guidelines were thorough and similar, Chairman Ed Hall volunteered to combine them into one document and present the guideline suggestions at the next Council meeting.
- 6. Speaker roster questionnaire: Questionnaires were passed out in order to bring the 1995 Speaker's Roster

up-to-date. Societies were asked to submit a list of their 1994 Programs to Chairman Ed Hall. This list will be added to the Speaker's Roster.

- 7. World Bromeliad Conference. James Boynton of Florida West Coast submitted the winning entry of "Orlandiana '96 for the theme of the World Bromeliad Conference to be held in Orlando in July of '96. Ed Hall passed out fliers to determine interest in pre and post conference tours. The fliers are to be presented to the societies membership and returned to Ed Hall by July '95. The exact dates for World Conference events were requested and will be recorded in the next quarters' minutes.
- 8. Mulford Foster video tapes. A motion was made, seconded and carried that the Foster tapes in the possession of Carol Johnson be donated to the World Bromeliad Conference.
- 9. Fifth International Cryptanthus Conference and Bromeliad Show: Tom Wolfe reported that the International Cryptanthus Conference and a BSI judged bromeliad show will be held Sept. 14-17, 1995 at the Wyndham Harbor Island Hotel in Tampa. Information fliers were distributed for Florida Council membership. A special rate of \$84 per night was obtained at the Wyndham Hotel.
- 10. Extravaganza '95: Carol Johnson moved that Central Florida host the one day Extravaganza at Leu Gardens, providing the facility is available. The motion was seconded and passed.
- 11. Judges School: Betty Ann Prevatt, Fla-Ga. Registrar, reported that the first session of the School will be held Saturday March 4, at Flamingo Gardens in Davie, Fl. Valerie Steckler will conduct the first school. Thereafter, sessions will be conducted by Florida instructors under the leadership of Bill Frazel. Carol Johnson made the motion that the Registrar be allowed to make all decisions regarding the Judges School. The motion was seconded and passed. Al Muzzell moved that Betty Ann Prevatt be reimbursed for Ms. Steckler's plane fare. Judges School fees, less expenses, will then be returned to the Fla. Council. The motion was seconded and passed. There are, at present, 18 students signed up for the school but more students are welcome. The schools will be held every six months for three years.

The site schedule is as follows: Broward, Fort Myers, Tampa, Orlando and Fort Myers. The host societies will make all arrangements but will not be responsible for expenses.

12. Miscellaneous: Al Muzzell volunteered to try to reactivate the Florida Council slide library.

Judy Patterson made the motion, it was seconded and carried that the next Florida Council meeting be held April 1, 1995 in Tampa.

On March 10-12 a Florida Federation of Garden Clubs sponsored show featuring bromeliads will be held at the Tampa Garden Center. Annual judged shows will be held in Sarasota in April and Miami in May.

The meeting was adjourned at 3:10 pm.

HORTICULTURAL MISTAKES

The title of this paper should perhaps be "Hybridizing Errors", but since I am in no way an authority, there should be some latitude to hedge. These are all my opinions, and I would welcome any alternate view.


The majority of bi-generic crosses are terrible mistakes. There are a few exceptions, but most of those plants which are in our collections are weak, degenerate growers which deteriorate with each succeeding generation In many cases, the bi-generic cross is wishful thinking, and the resulting offspring is merely a selfing of one parent or the other.

I do not believe there is even one successful bi-generic produced from Pitcairnioideae parents. Any resulting progeny usually die before blooming. Dyckias, pitcairnias, puya, hechtia--all have diverse seed forms which are not conducive to cross pollination. The bromelioideae subfamily is where the majority of the bi-generic crosses have been made. Many of these are mules and never bloom. I have in my greenhouse a cross between Aechmea ludemanniana and Billbergia pyramidalis (source ?). In the fifteen years I have been growing this plant it has never bloomed and it responds to Florel with a mess of offsets, so I cannot get rid of it. XNeomea Meadiana is a lovely plant, but it never produces roots and over the years has produced fewer and fewer blooms and offsets. The XNeophytums are probably the best of the bi-generics, but that is undoubtedly due to the caliber of the hybridizers. Also, these plants have good and bad years and it is hard to know exactly what their cultural wants are. The one time that I bloomed XNeotanthus Cardboard it produced seed, and the seed produced nondescript Neoregelias. The mother XNeotanthus then died and produced no offsets. My latest experience is a XCanmea which developed in a batch of Aechmea chantinii seedlings. There is so much random cross pollination among the Aechmeas in my greenhouse that I no longer harvest the thousands of seeds produced.

Hybridizers in the Tillandsioideae subfamily are striving to produce bi-generic plants with pollen sterile blooms which maintain color and form for a long time and are hence good commercial items. There are some nice ones, i.e. X Guzvriesea Marion and X Vrieslandia (V. Marieae X T. multicaulis, DeLeon). There will be more, and because the hybridizers of these plants are planning carefully, this subfamily will, in time, produce the most beautiful bi-generics.

I am all for hybridizing within the subfamilies, but leave bi-generics alone. Just to see if it can be done is not a good enough reason.

It would be interesting to hear your views on this subject.
