

It was so well received that some people even wanted to have it here EVERY YEAR. (Sorry, but it will continue to rotate around the statenext year in Daytona Beach).

Everyone who worked behind the scenes and at the event can be very proud that the Bromeliad Society of Central Florida will be remembered as hosting a world class event. Many BSCF members worked long hours that day-some from before sunrise until after midnight & even the next morning. We don't have an accurate list of everyone who worked but a huge THANK YOU goes to everyone who came to work, buy plants & just visit with friends. The Extravaganza Committee members were Ed Hall, Chairman; Eloise Beach, John Boardman, Pam Flesher, Nancy Hall, Kathy Law and Jim Pearce.

The Home & Garden TV Network sent a crew from Canada to film at the Extravaganza, Leu Gardens & some BSCF members' gardens.

Maybe you will catch that episode on TV.

The Plant Sale was stuffed with an amazing variety of bromeliads- 54 tables overflowed with colorful, unusual, rare, and many bargain-priced plants. Recorded music from South American bands enter-

tained the shoppers. The Bromeliad Society International was selling back issues of the Journal and you could even buy copies of the very rare out-of-print GRANDE Magazine. Equally amazing was the fact that the room was filled with buyers ALL DAY. It was a feeding frenzy. People just kept shopping & buying more. The big effort spent on publicity through live radio spots by Eloise Beach plus great support by the Orlando Sentinel, neighborhood papers, newspapers throughout the state as well as local radio & TV public service announcements really brought out the general public. Our small staff of plant sale workers did a tremendous job of handling the big crowds. The plant sellers who took the time to participate were also extremely happy.

The membership drive brought in 8 new members for BSCF and one new member for the Bromeliad Society International.

The hourly seminars were well attended and lots of prizes were awarded to those who came to learn. Our seven guest speakers, invited by John Boardman, were well prepared and gave very interesting presentations. Thanks again to: Wilma Paulauskas, Orlando; Barbra Larson, Gainesville; Tom Wolfe, Lutz; Grant Groves, Winter Garden; Beth Lamb, Sebring; John Russell, Sanford; and Michael Andreas, Merritt Island.

Another popular & successful feature was the Snack Bar offering beverages, snacks, sandwiches & salads. Members did a great job serving the hungry people. Special thanks to nonmember Irene Beach (Eloise's mother) who, decked out in that long white apron, worked the entire day without a break, smiling & entertaining everyone who stopped.

Workers at the Plant Holding Booth did a fine job of plant-sitting and checking in the auction donations. They were always busy because people were buying box after box full of plants.

We received lots of compliments for our educational displays. One of the most popular was "Aechmea orlandiana & Relatives" coordinated by Eloise Beach. George & Irene Aldrich provided an outstanding piece of driftwood that served as a focal point for the interesting grouping of Aechmea orlandiana varieties & hybrids. Plants for this display were provided by the Aldrich's, Betsy McCrory, Moyna Prince of Miami, & Eloise Beach. Michael Andreas provided color photos of Ae. orlandiana varieties and Herbert Henry helped with the setup. The plants were labeled and stories about their origin were posted.

Florida's native bromeliads were well represented. Herbert Henry did an excellent job of displaying the natives and providing names & information about each species. A highlight of the display was a beautiful blooming

Guzmania monostachia variegata—a very rare plant. Barbra Larson brought an informative display all the way from Gainesville about the Evil Weevil and also provided the continuous computer presentations featuring a weevil update and a survey of all the Florida native bromeliads including photos of blooming specimens. We even had a display about growing Tillandsias from seed with live seedlings.

Many people enjoyed reading about the history of the Florida Council of Bromeliad Societies and looking at information about each of the 12 bromeliad societies in Florida-including most society newsletters. Eloise Beach gathered & printed the information and Kathy Law & Herbert Henry helped set it up. There was also a handout with the society info. Other displays included a blooming pineapple (contrasted with Spanish Moss) offering instructional flyers on how to grow a pineapple and a display about the 15th World Bromeliad Conference. Thanks to Grant & Magali Groves for providing many colorful bromeliads to decorate the Civic Center lobby.

Everyone was anticipating the 4:30 pm Raffle drawing and the \$150 bromeliad book was won by BSCF member, Herbert Henry. We gave away 22 other prizes to lucky winners. The raffle was a

great success.

Even though the Sale closed at 5 p.m., we had to remove the displays and get ready for the cash bar and evening banquet activities.

It was sad that less than 100 people attended the banquet & auction, but those people were rewarded with a fun-filled evening they will long remember. The tables were decorated with beautiful centerpieces featuring many mounted bromeliads and each attendee received a tissuecultured plant from Twyford International. After the delicious buffet, we played Bromeliad Bingo with Ed Hall being a very entertaining Bingo caller. Four winners took home blooming bromeliads & Florida lottery tickets. Those prizes were displayed on a table "guarded" by honorary BSCF member "Frank N. Stein" who was a colorful lighted 3' tall Frankenstein figure. Since this was the weekend before Halloween, Kathy Law & Jim Mahler carved several very creative jack-o-lanterns that were on display all day.

The grand prize Bingo winners were BSCF members Sam Wilson (\$150 bromeliad book) and Matilda Morabito (World Conference Registration). Another World Conference Registration was won by Kathy Risley of Clearwater (Florida West Coast Bromeliad Society).

The Rare Plant Auction had 48 items available for bidding. Caloosahatchee Bromeliad Society members, Betty Ann Prevatt, Eleanor Kinzie & Dianne Molnar, kept all the bidding records in perfect order. Each of the 12 societies in Florida was requested to donate 6 items, but unfortunately some did not support the auction too well. (Central Florida-10 items; Broward-7; FL West Coast -7; Caloosahatchee -5; South Florida-5; Seminole-4; FL East Coast-3: Jax-Gainesville-2; Sarasota-2; Tampa Bay-2; anonymous-1; Boca Raton-0; Treasure Coast-0)

The auction was still a tremendous success because the bidding was very spirited. (Some said BSCF bartender, Bob O'Bryant, was "very generous.") BSCF V.P.

John Boardman won the most exciting bidding war, paying \$215 for the right to own & name one of Don Beadle's last hybrids: Billbergia 'Carrone's Black Bill' x 'Arriba.' That was the top price of the evening. Everybody was talking about Ed Hall modeling a tee shirt that was up for auction. You had to see it to believe it! The

We were also happy to see Bert & Grace Foster. The Maitland Civic Center provided a comfortable setting for renewing friendships, making new friends and exchanging plant stories. The 2001 Bromeliad Extravaganza was a huge success for our society in so many ways. It was a financial success as well, with a profit for BSCF exceeding \$2,500. Thanks to everyone who took the time to support this event and the Bromeliad Society of Central Florida. Quoting from the Sarasota Bromeliad Society November newsletter: "The Extravaganza ... was an event you should not have missed."

#### Minutes of the Florida Council of Bromeliad Societies 10/13/01

Meeting was hosted by Dr. Karl and Kris Green of BSSF at the clubhouse of the Royal Harbour Yacht Club in Miami and came to order at 1:10p.m. with 16 members present.

#### Secretary's Report:

The Chairman reported that the Secretary had resigned. In his absence, the minutes of the meeting were taken by Jay Thurrott. 16 members were present. Ed Hall made a motion to accept the minutes from the last meeting as recorded in the newsletter. Motion passed.

#### Treasurer's Report:

Ted Nuse submitted the Treasurer's report. He reported that a check has been received from the state for the final balance of grant monies for the Weevil Fund. A reminder was given that dues for each society will be due in January and that each check should be accompanied by a current roster of members. All member societies are presently paid up for 2001. It was noted that the cost of preparing the newsletter has increased and that additional income would be needed to offset expenses by the Council. Dr. Barbara Larson raised the guestion of possibly increasing the annual dues. Following discussion, a motion was made by Karl Green and seconded by Inez Dolatowski that dues be increased by \$1/member per year. Discussion concerning reference to dues in the proposed Standing Rules (new to the By-Laws revision) led to the motion being withdrawn until the revisions to the By-Laws were passed. The Treasurer notified the Council of his wish to resign effective Jan. 2002 due to other commitments during the coming year.

#### Webmaster's Report:

Michael Andreas was unable to attend. Copies of the Web-master's report were distributed. Information about this year's Extravaganza has been posted and updated. A memorial page for Carol and Geoff Johnson was posted. This year's fee (\$239.40) for the web site has been paid and will be next due on 7/23/02. The new Tillandsia book Tillandsia 1 has listed the Council website as one of its sources.

#### Weevil Report:

Dr. Babara Larson submitted a Weevil Project Update and reported the encouraging news that more flies had arrived from Ron Cave and that they were doing well.

Preparations are underway to get them out of quarantine. Additional greenhouse space has been provided for the rearing of plants to feed the weevils. The names of individuals who will be collecting seeds are needed immediately so that they will appear on the permit to collect in state parks. Phil Fenner of South Florida has volunteered to grow seeds for the project in addition to John Russell of Sanford. Ed Hall emphasized that seed must be grown only in state inspected nurseries.

Proposals have been submitted for grants from the Native Plant Conservation Initiative and the Gulf Stream Pipeline project.

#### Extravaganza Report:

Ed Hall presented an update on the 2001 Extravaganza. Plants for sale will be accepted Friday afternoon and early Saturday morning. Home and Garden TV network will be on site filming on Saturday morning.

# BSI and World Conference Reports:

Tom Wolfe reported on receiving authorization to purchase a cabinet for storage at Selby Gardens as part of an initiative to establish a World Bromeliad Center at Selby. He encouraged everyone to register at the hotel for the World Conference to help meet the room night commitment for the hotel.

#### Old Business: Bylaw Revision

Jay Thurrott reported that

several constructive comments had been received and addressed in the revisions to the By-Laws. He reviewed the most recent revisions and solicited any further remarks. Maureen Frazel made a motion that the By-Laws be accepted as presented. Ted Nuse seconded the motion. Motion was unanimously approved. Karl Green resubmitted his motion (seconded by Inez D.) to amend the Standing Rules to reflect a dues increase of \$1 per member per year. Motion carried unanimously. Dues of \$3/member plus \$10/society will be effective in January '02.

#### Speaker's Roster:

Tom Wolfe collected additions to a speakers list which he is compiling and will present it at the next meeting.

#### **New Business:**

Maureen Frazel made a motion, seconded by Karl Green that the Fall Council meeting be held in conjunction with the Extravaganza and that this scheduling carry through each year on the date of the Extravaganza. This will reduce travel by Council members who currently must travel to the October Council meeting in addition to the Extravaganza (which is usually in September or October). This will also affect the current scheduled list of rotation for societies to host the quarterly Council meetings. Motion carried unanimously.

A motion was made by Vicky Chirnside and seconded by Polly Pascal for the Council Chairman to review the proposed meeting schedule and host societies for upcoming years and make adjustments as may be called for with the objective to distribute meeting locations more evenly across the state each year. Motion carried unanimously.

The January '02 meeting will be conducted by the new slate of officers and will be at the University of Florida Nematology Department in Gainesville.

Ed Hall moved for adjournment. Compliments and thanks were expressed to Karl and Kris Green and Moyna Prince for making arrangements for the meeting and providing a wonderful lunch for everyone. Meeting adjourned at 3:00p.m.

Following the meeting Karl gave a tour of his greenhouse and his incredible collection of over 1000 species plants - many of which have not been released and are not available anywhere in the country.

# Weevil Project Update October 13, 2001

#### 1.) Biological control:

a.) Flies:

Ron Cave brought 4 adults and 30 puparia to Gainesville on September 20. We have changed the conditions under which the puparia are kept, and adult emergence has been very good. He sent an additional 14 puparia, which arrived Oct. 11. We will be receiving several shipments of additional flies in the coming months.

b.) Weevils:

We are modifying the method of rearing the Mexican bromeliad weevil, moving some of the rearing operation to the lab, to clear up greenhouse space in preparation for mass rearing the fly when a release permit is obtained.

#### b.) Plants:

The project has received a donation of 950 small *Tillandsia utriculata* plants from Driftwood Gardens, with additional plants to follow. We also received several mature *T. utriculata* and approximately 10,000 seedlings from the Gulfstream Pipeline construction on the western end (Hardee Co.). We will receive more plants next summer when construction reaches the eastern end (Martin Co.). We have started using additional greenhouse space provided by the UF Entomology Dept.

#### 2.) Seed collection:

available:

a.) Update on permits

A DPI permit is now available for Loxahatchee National Wildlife Refuge (Palm Beach County). Landowner permission is pending for the following: Florida Division of Forestry, Sarasota County Parks and Recreation, Martin County Parks and Recreation, and Florida's Turnpike.

b.) Updated collector lists from each society:

Societies that have not already done so should submit as soon as possible an updated list of members who will be participating in seed collecting. Florida Park Service will not issue a permit (to be valid for all state parks affected or potentially affected by the weevil) without listing all seed collectors. Anyone whose name is not included in the list submitted to the Park Service will have to request their own permit if they wish to collect in state parks.

c.) Seed growers:
Phil Fenner of Glades Botanical Garden (Glades Co.) has volunteered to grow seeds for the project. Seeds collected in the southern counties can be sent to him, while seeds collected farther north can be sent to John Russell.

3. Public outreach:

a.) An article about the weevil problem was published in the Fall issue of Harbor Happenings, the newsletter of the Charlotte Harbor National Estuary Program (http://www.charlotteharbornep.com).

b.) Display materials about the weevil problem and native Florida bromeliads were provided to Miami Beach Botanical Gardens for a bromeliad exhibit, which opened October 6 and will run to December 13.

# Weevil Project Update January 12, 2002

#### 1.) Biological control:

Since October, Ron Cave has sent 8 adult Admontia sp. flies and 121 puparia. He is attempting to begin a colony of Admontia in his lab in Honduras and will use some of the flies emerging from field-collected weevil larvae to do so. Despite several changes in conditions offered, we have not yet been able to achieve parasitism of the flies in the quarantine laboratory in Gainesville. Parasitized weevil larvae are still being collected in the field in Honduras.

- c.) A bromeliad symposium, including a field trip to collect seeds, will be held March 2 at Highlands Hammock State Park, 5931 Hammock Road, Sebring. The purpose is to educate the public about the weevil's effects on

bromeliads in the park and throughout the state. Dorothy Harris, the park ranger organizing the symposium, hopes to use the event to recruit volunteers to collect seeds in the park. On Seed Collecting – by Dr. Barbra Larson

Don't miss the chance to participate in the bromeliad seed collection project this spring! When plants grown from the seeds that are collected now are eventually reintroduced, they will each be returned to the place they were collected. If you want the bromeliad populations in your local parks to be represented in the seed that is collected, make sure that your parks aren't missed.

Permits are being requested for all county and state parks where bromeliads at risk are found. If you know of city parks or private land where you would like to collect seeds, let us know and we will try to get the appropriate permits for you. We have a list of people who have expressed an interest in collecting seeds this spring. A copy of the seed collecting instructions and updates on permits that are available will be sent to everyone on the list. We also need to keep the list complete, because several park departments are requesting lists of all potential seed collectors, to include their names directly on the permit.


